Phyllis S. Howe DISTRICT BOARD MEMBER AWARD SILICON VALLEY DISTRICT (2018-2019) Application Procedure

The California Academy of Nutrition and Dietetics Foundation (CANDF) Phyllis S. Howe Award is granted to a California Academy of Nutrition and Dietetics (CAND) District Board Member for the purpose of attending FNCE or PPW.

All applicants must be a current member of the Academy of Nutrition and Dietetics and requires specific CAND District Board Member service (Bay Area District, Silicon Valley District and Silicone Valley District, rotating every 3 years).

APPLICATION INSTRUCTIONS

The completed application and supporting materials are to be submitted to the CAND Central Office **by May 1, 2019**, via email to Pat Smith (scholarships@dietitian.org), with the last name of the applicant followed by HOWE DISTRICT BOARD MEMBER AWARD in the subject line. All documents must be in ONE (1) **pdf** file. The **pdf** file should be submitted in the following order:

- 1) Application Form
- 2) Letter of Application and a Resume from the applicant. The Letter of Application should include a discussion of District Board Member activities to-date.
- 3) Two Letters of Recommendation from Registered Dietitians that are from your current District.
 - References should address the applicant's District Board Member performance and potential for successful leadership at the District or State level.
 - For a confidential letter, please ask the recommender to email the Recommendation Letter and Recommendation Form directly to scholarships@dietitian.org with the applicant's last name in the subject line.

Award Criteria

Membership in Academy of Nutrition and Dietetics is required

District Board Member (One \$2000 scholarship)

1. Silicon Valley District (DVD) Board Member.
2. Funds will be provided to attend FNCE or PPW (via reimbursement or up-front pay). Proof of attendance and a one-page report of highlights from attending FNCE or PPW must be submitted within 30 days to the DVD President.
